APPLICATION PROCESS

ALL PROJECT SPONSORS:

- ★ All organizations must submit a Project Concept Form, due no later than one month before the Application Deadline
- ★ Upon approval of the Project Concept Form, you will be invited to submit the full Service Project Application
- ★ Service Project Application Packet must be the current version (expires 3.31.2016)

Round 1 (early Nov. – mid Dec.)	August 4, 2014	Late September
Round 2 (early Jan. – mid March)	September 15, 2014	Mid November
Round 3 (late March – late May)	December 15, 2014	Mid February
Round 4 (early June – mid July)	February 23, 2015	Late April

ABOUT OUR MEMBERS

- ★ Women and men, ages 18-24, who serve full-time for ten months
- ★ Recruited nationally and are from different social, cultural, and educational backgrounds
- ★ Some members are college graduates, some have some college background, some with high school diplomas, and a small percentage that are working towards their high school diploma
- ★ Select members are trained in chainsaw use, HAZWOPER, forklift use and Disaster Volunteer Management; all members are trained in First Aid/CPR and teambuilding
- ★ Eager to learn & to serve; generally few technical skills

WHAT NCCC PROVIDES

- ★ A team of 8-12 members who are supervised by a Team Leader
- ★ A Team Leader to coordinate and reside with each team (Team Leaders are not technical project supervisors, but are responsible for managing their teams and report to NCCC staff)
- ★ One 15-passenger van per team; fuel covered by NCCC (except in Hawai'i and Alaska where a means of transportation and fuel must be provided)
- ★ Limited funds specifically designated for the team to purchase groceries
- ★ Limited hand tools, basic personal protective equipment and housing supplies
- ★ All Members are fully covered by the provisions of the Federal Tort Claims Act (liability claims) and the Federal Employees Compensation Act (workers' compensation claims)
- ★ All Members are screened with a fingerprinted, national agency criminal history check (FBI) and checked against the national sex offender database

PROJECT SPONSORS MUST PROVIDE

- ★ All project materials, tools, equipment and related protective gear, including chaps for chainsaw use
- ★ All technical supervision to guarantee the necessary training for the tasks at hand (approx. 15-20 hours per week, depending on project work)
- ★ Orientation to your organization and community, as well as service learning opportunities to teach about the community need your project addresses
- ★ Lodging for the team to include access to a full kitchen for meal preparation (if meals are not provided), bathroom & shower facilities, at least two sleeping areas for men and women, and parking for one van
